

#### CHILDREN IN ORPHANAGES: A HIDDEN GLOBAL PROBLEM

An estimated 8 million children worldwide live in orphanages or residential institutions.

### Shockingly, 80% of these children are not orphans.

Most people see orphanages as a social good - or at least necessary - when in fact they often harm the very children they are supposed to protect. Most children are institutionalized because their parents are poor and cannot adequately provide for them. And while many institutions are established with good intentions, more than 80 years of research proves that raising children in orphanages harms their health and development, increases their exposure to abuse and puts them at risk of future criminal activity.

Children need families, not orphanages.



## WHY CHILDREN LIVE IN ORPHANAGES WHEN MANY HAVE FAMILIES

A spectrum of institutionalization exists - from well-intentioned, committed organizations to those that see an opportunity to make a profit right through to those managed by organized criminals who traffic children. In some countries, orphanages prey on families in vulnerable situations, actively recruiting them with promises of free education and healthcare. Circumstances such as war or natural disaster, discrimination on the grounds of ethnicity or disability, or simply extreme poverty make desperate parents seek help.

But the only support they are offered is a place for their child in the orphanage. And once the decision is made, parents are often discouraged from visiting or maintaining a relationship with their child. Over time relationships break down. Families come to believe their children are better off without them. Children may not even remember their family, or where they come from.

This outdated system of care can and must change.

Lumos has demonstrated time and again that, no matter what challenges are facing industrialized or developing nations, it is less expensive and more beneficial for children to be cared for by their families rather than in orphanages. When children remain with their families, and get the support they so desperately need, the outcome is far better for them, for their families, and for society.

Economic and political instability are not obstacles to transforming care systems for children.

But the process of change is complex. It requires a coordinated effort, investment, knowledge, expertise, and a long-term commitment. It requires your support.

#### We achieve this by:


TRANSFORMING SYSTEMS. Lumos works with governments, communities, families, caregivers and, most importantly, children, to transform outdated systems of care and protection. We help funders redirect money from orphanages to health, education and social services that meet the needs of all children.

CHANGING GLOBAL TRENDS. Lumos successfully advocates for change at the highest level of global decision-makers, to ensure that the UN, European Union and other regional political bodies are aware of the 8 million children hidden in orphanages and prioritize them in global actions to improve children's rights and child protection across the world. This shift in policy leads to action and impact on a massive scale.

SHIFTING DONOR FUNDING. Lumos works with the world's biggest funders of humanitarian aid and development to ensure that donor funding is diverted away from orphanages and is used to develop the services and systems needed to ensure children can be raised in families.

SHARING EXPERTISE. Lumos trains and shares knowledge with many organizations and governments. We document good practice, train professionals, politicians and community leaders, so that many other countries can also begin to bring children safely out of institutions, back to families.

CHANGING CHILDREN'S LIVES. Lumos works directly on the ground to rescue children from harmful orphanages and make sure they have access to all the help and support they need to grow up safely in families and develop to their full potential. This direct case work helps to demonstrate that change is possible and gives governments and communities the confidence they need to implement the larger-scale changes required.



By diverting existing financial support and donations away from orphanages and toward community-based services, it is possible to create a world where every child can live in a safe and caring family setting.

#### STORIES FROM OUR WORK

When Sonya's baby was born in 2015, she was told by doctors that he would not be able to walk and that he should be placed in an institution 100 miles away from her home in order to get medical treatment. But she was determined to keep her child, no matter what the doctors advised. Lumos worked tirelessly with social workers and the authorities for three months to successfully get her baby out of the institution and back home with Sonya, where they are now getting the support they needed, as a family, within their community.

She said "So far, his development is just as it should be... and my dream is that he will walk. And I will do my best to make this happen." No-one will fight for a child the way a parent will. Because of Lumos, Sonya and her son have a chance at a normal life.
